Our website uses cookies to distinguish you from other users of our website. This helps us to provide you with a good experience when you browse our website and also allows us to improve our site.

Cookies are small text files containing configuration information that are stored on your hard drive and linked to the browser you are using. These cookies enable the party that sets them (in this case us) to receive certain information.

The cookies we use help to determine how often our website is used and how many users our website has and enables you to fully utilise our service. Cookies cannot run programs or transfer viruses to your computer. They are intended to make the website as a whole more user-friendly and efficient.

This website uses transient cookies and persistent cookies.

Transient cookies are automatically deleted when you close your browser. These include session cookies, which store what is known as a session ID that allows various requests from your browser to be assigned to the same session. This enables your computer to be recognised when you return to our website. Session cookies are deleted when you log out or close your browser.

Persistent cookies are automatically deleted after a predetermined period of time, which may vary depending on the cookie. You can delete cookies at any time via your browser's security settings.

Most browsers are configured to automatically accept cookies. However, you can disable the storage of cookies or adjust your browser settings so that it notifies you whenever cookies are sent or automatically deletes them. You can also delete stored cookies from your hard drive at any time.

Please note that deleting cookies may result in reduced functionality and a limited user experience on our site. However, in general, our services can still be used with limited functionality even without cookies.

Functional cookies help improve our website's functionality and personalisation. They may be set by us or by third-party providers whose services we have added to our pages. The purpose of these cookies is to provide you with a more personalised experience on our website based on your previous visits. If you do not allow these cookies, some or all of these services may not function properly.

How can you manage cookies? When you visit our website for the first time, a pop-up window will inform you about cookies and ask you to accept them, manage your preferences or reject the cookies. You can also change your selection at any time and withdraw your consent for optional cookies.

Cookie settings are likely to impact the terms of access to the website. Rejecting all cookies may significantly affect your ability to access and use the website.

Cookie settings from your browser: Your browser can be configured to notify you of cookies placed on your device and prompt you to accept or reject them. This configuration is described in the browser's help menu, where you can adjust your cookie preferences.

Tracking tools and services

The respective data processing purposes and data categories can be derived from the corresponding tracking tools.

a) Google Analytics

We use Google Analytics, a web analytics service provided by Google LLC (1600 Amphitheatre Parkway, Mountain View, CA 94043, USA; 'Google'), for the purpose of ensuring the continual optimisation and user-oriented design of our website. We use this service within the framework of a data processing agreement.

In doing so, pseudonymised user profiles are created and cookies are used, i.e. text files that are stored on your computer and enable an analysis of your use of our website. The information about your use of this website that is generated by the cookie, including

- browser type/version,
- the operating system being used,
- referrer URL (the previously visited site),
- hostname of the accessing computer (IP address) and
- time of the server request,

is transmitted to a Google server in the US and stored there.

Google uses this information on our behalf to evaluate your use of the website, to compile reports on website activities for the website operator and to provide us with other services related to website usage and internet usage for market research purposes and the tailored design of these webpages. This information may also be transferred to third parties if doing so is required by law or third parties process this data on behalf of Google. Google will not merge the IP address transmitted as part of the Google Analytics framework with any other data held by Google. IP addresses are anonymised to ensure they cannot be linked to individuals (IP masking).

We have activated the IP anonymisation feature on this website. As a result, within member states of the European Union or other signatory states to the Agreement on the European Economic Area, your IP address is shortened by Google before being transmitted to the US. Only in exceptional cases will the full IP address be transmitted to a Google server in the US and shortened there. On behalf of the operator of this website, Google will use this information to evaluate your use of this website, compile reports on website activities and provide other services related to website and internet usage to the website operator. The IP



address transmitted by your browser as part of Google Analytics will not be merged with other data held by Google.

We use Google Analytics, including the features of Google Analytics 4 (GA4). GA4 allows us to analyse activities on our pages across multiple devices (e.g. accessing our pages via a laptop and later via a tablet). This is made possible by the pseudonymised assignment of a user ID to a user. Such an assignment occurs, for example, when you register for a customer account or log in to your customer account. However, no personal data is transmitted to Google. Even though GA4 adds additional features to Google Analytics, this does not mean that there will be any reduction in data protection measures such as IP masking or the browser add-on.

Demographic features in Google Analytics:

This website uses the 'demographic features' function of Google Analytics. This allows reports to be created that include information about the age, gender and interests of website visitors. This data is derived from Google's interest-based advertising as well as visitor data from third-party providers. This data cannot be associated with any specific individual. You can disable this function at any time via the ad settings on your Google account or generally prohibit the collection of your data by Google Analytics as described in the section 'Objection to data collection'.

b) Google Ads Conversion Tracking

This website uses Google Ads. Google Ads is an online advertising platform provided by Google LLC, 1600 Amphitheatre Parkway, Mountain View, CA 94043, USA ('Google').

We use the online advertising program 'Google Ads' and, as part of this, the service Google Ads Conversion Tracking. Google Ads Conversion Tracking is an analysis service provided by Google (see above). If you click on an ad placed by Google, a cookie for conversion tracking will be stored on your computer. These



cookies expire after 30 days, do not contain any personal data and therefore cannot be used to personally identify you.

If you visit certain pages of our website and the cookie has not yet expired, Google and we can recognise that you clicked on the ad and were redirected to this page. Each Google Ads customer receives a unique cookie. This ensures that cookies cannot be tracked across the websites of other Google Ads customers.

The information collected using the conversion cookie is used to create conversion statistics. This allows us to determine the total number of users who clicked on our ad and were redirected to a page tagged with a conversion tracking tag. However, we do not receive any information that could personally identify users.

The storage of conversion cookies is based on Article 6, Paragraph 1, Sentence 1, Letter (f) of the GDPR. The website operator has a legitimate interest in analysing user behaviour to optimise both its website and its advertising.

If you do not wish to participate in tracking, you can object to this use by preventing the installation of cookies via the appropriate settings in your browser software (opt-out option). c) Google Ads audiences/Dynamic Remarketing

Our website uses the features of Google Ads audiences in combination with the cross-device capabilities of Google Ads and tools available through the Google Marketing Platform. The provider is Google LLC, 1600 Amphitheatre Parkway, Mountain View, CA 94043, USA.

These features enable the advertising audiences created with Google Ads audiences to be linked with the cross-device capabilities of Google Ads and the tools within the Google Marketing Platform, such as Floodlight tags. This allows interest-based, personalised advertising messages that were tailored to you based on your previous usage and browsing behaviour on one device (e.g. smartphone) to also be displayed on another one of your devices (e.g. tablet or PC).

If you have given the relevant consent, Google links your web and app browsing history to your Google account for this purpose. In this way, the same personalised advertising messages can be shown on any device on which you are signed into your Google account.

To support this function, Google Analytics collects Google-authenticated user IDs, which are temporarily linked to our Google Analytics data to define and create audiences for cross-device advertising.

d) Google Marketing Platform tools/Floodlight

Google Marketing Platform tools, including Floodlight, are services provided by Google LLC, 1600 Amphitheatre Parkway, Mountain View, CA 94043, USA ('Google'). These tools use cookies to present you with advertisements that are relevant to your interests. A pseudonymous identification number (ID) is assigned to your browser to track which ads have been displayed in your browser and which ads have been clicked. According to Google, the cookies do not contain any personal data. The use of these cookies enables Google and its partner websites to serve ads based on previous visits to our website or other websites on the internet. The information generated by these cookies is sent by Google to a server in the US and stored there. Google only shares this information with third parties when required by law or as part of data processing agreements. Under no circumstances will Google merge your data with other data collected by Google.

e) Google Tag Manager

This website uses Google Tag Manager. This service allows website tags to be managed through an interface. f) GA audiences

This website uses GA audiences to collect and store data and create pseudonymised user profiles. GA audiences is a feature within Google Analytics 4, a web analytics service provided by Google LLC, 1600 Amphitheatre Parkway, Mountain View, CA 94043, USA ('Google'). This technology enables users who have previously visited our website and online services to see targeted advertisements from us on other external websites within the Google Partner Network. This is done by placing a cookie on your computer, which analyses user behaviour during visits to the website and can subsequently be used for targeted product recommendations and interest-based advertising. When this cookie is set, no personal data is stored or processed. We use Google Search Console on our website. It also allows us to group this data into categories, such as those previously stated. We use the information provided by Google Search Console to evaluate the use of our online services and optimise our website. h) Bugsnag

To identify and resolve technical malfunctions on our website, we use the application Bugsnag, a service provided by Bugsnag Inc., 110 Sutter St, Suite 1000, San Francisco, CA 94104, USA ('Bugsnag'). In the event of a malfunction, the IP address being accessed, data about user settings (e.g. the browser being used), details about the page where the malfunction occurred and any data entered on that page are sent to Bugsnag. To do this, Bugsnag uses cookies, which are small text files stored on your device. In the event of an error, technical data, such as browser information, details about the page on our website that was accessed and the IP address being accessed, are sent in anonymised form to a server in the US that Bugsnag operates and stored there. Bugsnag uses this information on our behalf to analyse your use of our website, identify the source of the error and enable us to fix the issue and optimise our application.

We use Bugsnag to efficiently resolve errors and optimise our website. This constitutes our legitimate interest as regards the processing of the aforementioned data via this third-party provider.

You can prevent cookies from being installed by deleting existing cookies and disabling the storage of cookies in your web browser settings. Please note that in this case, you may not be able to fully use all the features of our website. You can also object to the collection and sharing of personal data or prevent the

i) Awin

We use the services of Awin AG, a global affiliate marketing network headquartered at Landsberger Allee 104 BC, 10249 Berlin, Germany ('Awin'). Awin enables the provision of our advertising links by third parties (affiliate marketing). Our aim in using these services is to show you advertisements that are relevant to you and make our website more engaging for you.

Awin stores and processes information about your user behaviour on our website. To do so, Awin uses, among other things, cookies, which are small text files stored locally in the cache of your web browser on your device, that make it possible to analyse your use of our website.

I) Criteo

We use Criteo on our website to display personalised advertisements. Criteo is a service provided by Criteo SA, 32 Rue Blanche, 75009 Paris, referred to below as 'Criteo'.

This processing only takes place if you have consented to the use of Criteo cookies in the cookie consent tool or on the privacy page.

Information about your visit to our website and your activities on our advertising partners' websites is collected using tracking cookies and similar storage technologies. This information includes, for example, the number of pages you viewed, the search function you used, details about your device (device type, operating system, version) or your location. To do this, Criteo uses a technical ID to record the pages you visited and your search behaviour. According to Criteo, it is not possible to identify you as a person using these means; only anonymous information about your potential interests is collected.

Social Media Plug-ins

We use social plug-ins for the social networks YouTube, Vimeo, Meta and TikTok on our website. The underlying advertising purpose is considered a legitimate interest within the meaning of the GDPR. a) YouTube
